
Bridgetown Invitational Tournament Rules – 2026

Tournament Rules & Eligibility:

1. The Bridgetown Invitational Tournament (BIT) is a mixed, adult-only (18+) competition bowling tournament open by invitation only. It is required that all entrants hold current season adult USBC membership cards or purchase adult standard membership prior to competing. **An individual may apply for adult standard membership by paying the USBC membership fee of \$30.** If an individual does not want to pay full \$30 yearly membership fee, BIT maintains a Moral Support Tournament Certification for non-members of USBC (See Rule 301a). Non-USBC members may qualify for entry by payment of a \$5.00 one-time tournament competitor fee (USBC Rule #300c) prior to competing. Payment of the fee prior to competing entitles the entrant to compete subject to the USBC rules and jurisdiction. Competitors who pay this one-time Moral Support tournament fee are not eligible for USBC awards (USBC [Rule #300c](#)).
 - 1A. In addition, as an IGBO-affiliated member tournament, BIT now requires individual entrant competitors/participants of the tournament to either have current annual membership with an IGBO-member league or the competitor/participant will need to apply for an IGBO associate membership by paying the \$25 annual IGBO associate membership fee, paid during registration. This requirement is in addition to USBC membership. Additionally, IGBO associate membership qualifies the individual to be eligible for IGBO-specific performance awards at this tournament and other IGBO member tournaments throughout the year, as well as eligibility for the IGBO Annual tournament in Las Vegas, May 14-17, 2026.
 - 1B. Only one (1) professional bowler per team will be allowed. A professional bowler is defined as any person who has been a “card-carrying” member of a professional bowling organization within the past 24 months preceding the 2026 Bridgetown Invitational. “Card carrying” is defined as anyone who has competed/participated in a PBA / PWBA / PBA 50 / Regional PBA tournament (regionally, nationally, or internationally) in the 24 months preceding the 2026 tournament. **All pros must self-disclose or they will be disqualified. All pros enter at tournament scratch. Average reductions inquire with tournament director.**
 - 1C. In accordance with IGBO DEI, the Women’s competition category for this tournament is open to transgender females holding a government issued female ID.
2. BIT is a USBC certified, and IGBO affiliated tournament and the following shall apply concerning averages verified on www.Bowl.com, LeagueSecretary.com and IGBO-TAD (Tournament Average Database), average verification will be done Feb 9, 2026:
 - 2A. If a bowler has an IGBO-TAD tournament average, with minimum 21 games within past 12 months as of Feb 9, 2026, then the IGBO tournament average will be used.
 - 2B. If the bowler does not have sufficient games for a TAD average, then the bowler shall use their USBC composite 2024/2025 league average (includes Summer 2025) that consists of a minimum of 21 games per Bowl.com.
 - 2C. If 2A and 2B does not exist, the bowler shall use their highest 2024/2025 league average that consists of a minimum of 21 games.

- 2D. If none of above 2A, 2B and 2C exist, the bowler shall use their highest 2023/2024 league average that consists of a minimum of 21 games.
- 2E. All others will enter at an average determined by the tournament director per USBC Rule 319b.
- 2F. Team Average Cap – The Bridgetown Invitational Tournament will observe a maximum team average cap of 880. Teams may not be accepted if the total team average exceeds this cap.
- 2G. Handicap for the tournament will be based on 100% of difference between highest bowler verified average.
3. It is the bowler's responsibility to verify the accuracy of his/her average, whether originally submitted by the bowler, his/her team captain, or others. Failure to use the correct average, if the submitted average is lower than the correct average, will result in disqualification unless corrected before the completion of the first game of the first event bowled. Please refer to USBC Rule 319a-3 & 4. USBC rule 319-2a is not in effect for this tournament. Registration questions should be directed to bittournamentdirector@gmail.com.
4. A bowler who has qualified for: a prize of \$500 or more in any event; total combined prize winnings of \$750 or more in any one tournament or total combined prize winnings of \$1,250 or more in all tournaments within the previous 12-month period must report the amount of the prize; the actual score bowled to qualify for the prize and the prize position for possible re-rating. Such re-rating must be done before the entrant bowls. USBC Rule 319d will be enforced and will apply to all entrants.
5. The average of any bowler may be adjusted by the Tournament Director(s) upon recommendation of the Greater Portland USBC Association of the bowler in question or at the Tournament Director's discretion. Any adjustment must be made before the entrant bowls.
6. There will be **NO REFUNDS** after an entry has been accepted by the BIT Tournament Committee.
7. Entries must be accompanied by the full amount of fees in the form of internet payment (PayPal via registration website), or contact treasurer@bitbowl.org for alternative payment methods (CashApp or Venmo). Bridgetown Invitational Tournament 2026 registration will only be available on-line. The BIT entry deadline is 12midnight Pacific time Monday March 2, 2026. All teams must be paid in full by that date. Also, all entries must include each entering bowler's physical address, phone number, email address (same email used at other IGBO tournaments), USBC#, leagues bowls/secretary contact information, and payment in full for the tournament fees, optional events and other amounts due in order for the registration to be complete for that team.
8. Bowlers may bowl only once. The event consists of nine games across 3 events: 3 games team, 3 games singles, 3 games doubles, on a modified house oil pattern (league shot). Optional scratch masters event is a separate tournament with separate tournament fee, rules, and oil pattern.
9. Score corrections must be made by a member of the tournament committee or bowling house staff.

10. All claims of error must be submitted, in writing, to the Tournament Director(s) within thirty (30) minutes after the bowler or team has bowled. In matters of dispute, the Tournament Director(s) decision will be final, unless an appeal is made in accordance with USBC Rule 329.
11. Substitutes will be allowed for emergencies only and at the BIT Tournament Directors discretion.
12. No pacers shall be allowed.
13. Late bowlers shall start bowling in the frame in which they are prepared to bowl; prior frames will be scored zero. The score for an absent bowler will be zero (0). The Tournament Director may authorize, together with the BIT Tournament Committee's input, a different schedule of events in case of emergency.
14. Cash Prizes: We are paying 1:8 singles, doubles, and team events.
15. Optional, paid events prizes: (events paid for during check-out will incur a \$5 transaction fee)
 - "Ross Island Bridge Mystery Doubles": \$10/entry, one entry can be purchased; pre-purchase entry during on-line registration or at Friday registration table before team event. Separate pot with 80% payout and expected cash ratio (based on 20 entries) is 1:8; all of your scores and random partner scores with your handicaps combined. Only the person with paid entry gets the payout, the mystery double person does not win anything but admiration from their mystery doubles partner.
 - "The Bridge is still standing" skill shot drawing: \$1/ticket, multiple tickets can be purchased; pre-purchase on-line, at registration table and can purchase day of each event, 50/50 payout). If your ticket is drawn, you will draw a card between 3-8 and in order to win you must LEAVE standing the number of pins on your card. If the person misses, the pot rolls over to the next event. Additional tickets can be purchased before the next drawing at the next event. If it rolls over to the end of the last event, then we will draw until someone wins.
 - Optional all events scratch: \$10 per entry per person; pre-purchase entries during on-line registration or at Friday registration table before team event. All scratch scores without handicap.
 - Optional all events handicap: \$10 per entry per person; pre-purchase entries during on-line registration or at Friday registration table before team event. All scores with handicap.
 - Brackets: \$5 per entry, multiples can be purchased, cash only, day of event and cannot be pre-purchased, brackets are intended to be paid the day of the event.
 - BIT Scratch Masters will be run as a separate tournament with its own cash prize fund by division. See BIT Scratch Masters Tournament Rules for more details. Pre-purchase entries during on-line registration or at Friday registration table.
16. Optional raffles for cash prizes/awards: (raffles paid for during check-out will incur a \$5 transaction fee)
 - Rainbow pack raffle tickets: 60 tickets for \$30 if pre-purchased during on-line registration, otherwise 30 tickets for \$20 at registration table on Friday at registration table before team event. Cash prizes and sponsor prizes for tickets drawn.
 - Ball Raffle tickets: 10 tickets for \$20, can be purchased during on-line registration or at Friday registration table. Limit win 1 ball per person; if same person gets drawn a second time for ball raffle they will win a different surprise.

- 50/50 mega raffle: \$10 per ticket, \$500 awarded if all 100 tickets sold. Can be pre-purchased during on-line registration, Friday registration table, and/or during Team, Singles, Doubles events until all 100 tickets are sold. Need not be present to win.
17. All bowling events will be held at SuperPlay Bowling Center in Beaverton, Oregon from Friday March 13 thru Sunday March 15, 2025. Bowlers will be allowed a 10 minute practice session. Bowlers are not permitted to practice on their assigned lanes on their scheduled day of bowling other than the practice session prior to the start of each shift.
 18. All bowlers must initial their scores on the recap sheet after each event. All scores will be verified against bowling center computers.
 19. There are a maximum of 24 teams allowed for this tournament.
 20. Payouts: Payouts for the tournament will be paid in accordance with USBC Rules. Payouts will be made by check within 30 days following the close of the tournament. (Thus the importance of accurate and complete mailing addresses and phone numbers during registration for every entering bowler!) Uncashed payout checks after 90 days from payout date will be considered donated back to BIT, minus \$35 cancelled check fee (donation letter can be provided).
 21. Tournament entry fee breakdown: \$135
 - Lineage \$45.00
 - Prize Fund \$62.50
 - IGBO \$2.00
 - Other Expenses \$25.50** (Free entries won as prizes at other IGBO events are not eligible for raffles that may be included as part of the tournament entry fee.)
 22. The financial statement for the tournament will be provided to all bowlers upon request after 30 days following the close of the tournament.
 23. Dress Attire: Bowling attire appreciated but not required; common sense shall rule. No earbuds/headphones permitted on lanes while bowling per USBC rules. No hats indoors. Tournament director will have final decision on attire.
 24. The tournament committee may make provisions for a bowler to “participate” (“participants”) versus “compete” in the tournament. “Participating” removes that bowler’s scores from competition and the bowler is ineligible to win prizes, awards, or funds for any and all events, brackets, and/or side pot games. “Participants” pay full entry.

Code of Conduct for all participating bowlers, partners, volunteers and supporters:

- Be respectful and courteous to all people (bowlers, spectators, house personnel)
- Always display good sportsmanship

- Do not engage in any behavior which is threatening to others, verbal abuse, physical abuse, threats, anger, or inappropriate language. **Anyone displaying this behavior, either on the premises or on social media, can be disqualified from participation in the tournament and escorted from the premises.**
- All bowlers have an invitation unless they are notified of it being pulled.
- Score corrections may only be made by the house or by a member of the BIT committee.

Dress Attire:

- Bowling attire appreciated but not required; common sense shall rule.
- NO earbuds/headphones permitted on lanes while bowling.
- No hats indoors.
- Tournament director will have final decision on attire.

Tournament Director has supervisory control of all parts of the tournament operation. The decision of tournament director shall be final.

COVID-safe

We know that the world has changed and there is always going to be uncertainty around events in the age of a pandemic, so here is our approach to making this work: SHOULD IT PROVE NECESSARY!

- The event will be fully COVID-safe and compliant above and beyond any basic government health requirements to do what we reasonably can to protect your health and safety and that of all attendees. That will include appropriate social distancing and other measures. We rely upon the state of Oregon and Washington County and will set parameters around masks, etc. based on their recommendations at the time of the event.
- COVID cancellation: if the event is cancelled or must be rescheduled due to COVID issues, we will offer you a full refund.
- It's in everyone's interest to ensure anyone who feels unwell stays away from events, so if you are showing any COVID-like symptoms please let us know and we will find a substitute to bowl in your place.
